Information regarding the legal merger of the Danone companies

Dear Sir or Madam,

With this letter we would like to inform you that as of November 01, 2022, Danone in Switzerland will merge the four previously independent business units - Danone Milk Fresh, Danone Waters, Alpro and Nutricia Milupa - into a strong overall company through a merger. The role of DACH Managing Director will be assumed by Christine Siemssen, who has already been with Danone for 25 years in various functions. The management in Switzerland will be taken over by Mr. Sandro Tichelli.

Why?

The aim is to create a single Danone unit in Switzerland for the distribution and sale of all our products and services on the market. This will allow us to serve our customers even better. This letter serves only as a notification of the transfer, which will not affect our business relationships unless otherwise communicated. All existing contracts, rights and obligations will automatically be transferred to **Danone Schweiz AG**.

What do we need from you?

- If you are a supplier of all Danone companies mentioned above, please create a new customer **Danone Schweiz AG** by using the information below.
